- B. Welcome and Introductions - *Dana Arciniegas*, President
  - a. Attendees: Dana Arciniegas, Fr. Dan Folwaczny, Dana Kelly, Chrissy LaPenna, Rita Lugo, Maria Nardulli, Jerold Parks, Lauren Shaffer, Erin Sloan-Beesley, Debbie Stroh
- C. Presidents Report –*Dana Arciniegas*
  - a. Easter Egg Hunt – April 1<sup>st</sup>
    - ii. Purchased pre-stuffed eggs for preschool and Kindergarten classes
    - iii. Each child will get about 4 eggs (stuffed with slime and other trinkets); iii. teachers will put on mini egg hunt within classroom, following guidelines
  - b. Jr. High Virtual Escape Room
    - i. Surveys went out to 5-8 grade parents
      - 1. 24 responses received (surveyed on date, time, cost, etc)- trying to gauge interest; mostly positive interest; bit of pushback on cost (\$35 is high end, could turn out to be lower if more students attend)
    - ii. Discussion was held on whether or not we could refund money if there was an overage. It would be difficult to offer a direct refund, but we could put any overage back into another junior high event or activity.
  - c. Parent/Daughter/Son events will need to be postponed mostly due to pricing issues. We are not able to hold some of these at school as we traditionally do.
  - d. Games Day- was scheduled for May 31<sup>st</sup>
    - ii. We will not be able to do the traditional day – looking into food trucks/Kona ice trucks with families as an alternative

  - a. School Board Update – Main focus is the annual Gala, which will be a virtual event held Saturday, April 17<sup>th</sup>.
